Liz shared that the class is a delight to work with and they are very eager learners. She also shared how impressed she was with the class during a recent "Part of the body" unit.

C. Summer Outdoor Learning Recap

Alyson Clendenen shared with the Board the recent SOL program. Her Recap included the many staff members involved and some of the highlights and challenges of the program especially the smoke issue from statewide forest fires. Student participation was very good and consistent during the days of operation. Alyson shared that the students and parents were happy with the program as it was a different approach to summer school instead of the traditional classroom-based summer school.

Joel Anderson reported that during OCSD's recent state testing several of the Chromebooks did not have the appropriate software but they were quickly upgraded. Joel also stated his ongoing concerns that large districts appear to have more impact on statewide decision-making than small schools do. He wants to make sure that the voice of the small school is heard at the statewide level.
